

STREETSBORO PARKS AND RECREATION

Park Rules

The Park rules and regulations, adopted by the Parks and Recreation Department, exist to protect both the park patron and the park facilities, and are enforced by the Parks and Recreations Department, the Department of Public Grounds and Facilities and the Department of Public Service.

1. The City Park opens at 8:00am and closes at dark.
2. There are no alcoholic beverages of any kind permitted in the City Park.
3. There is no gambling permitted in the City Park in conjunction with the Ohio Revised Code. Only those non-profit/charitable organizations that qualify under guidelines by the Ohio Attorney General's office and who with prior written permission by the Mayor and Parks and Recreation Department Director may use the park for fundraising/benefit events. 4. Soliciting is prohibited on park grounds without permission from the Parks and Recreation Department.
5. The ball diamonds may be used by anyone; however, the Parks and Recreation Department, high school games and organized league play will take first priority. For scheduling information contact the Parks and Recreation Department. The fields may not be used in weather or in conditions that may cause damage to surfaces.
6. The pavilion, stage area, tennis courts and volleyball courts may be used by anyone during regular park hours unless previously reserved. To avoid confusion, large groups should reserve these facilities in advance by contacting the Parks and Recreation Department. All other areas of the park may be used on a first come, first served basis.
7. Skate park rules are posted near the skate park and should be adhered to by all participants. Only skate boards and in-line skates are permitted on the skate park at all times. No bikes or other types of riding devices are permitted.
8. Maximum speed on all park roadways is 10 mph.
9. Street legal licensed motorized vehicles must remain on park road surfaces at all times. No other vehicles are permitted in the park.
10. No travel or parking off of road surfaces with the exception of Streetsboro City Vehicles.
11. Through traffic on park roadways is prohibited.
12. Trash containers have been provided throughout the City Park. Large groups that use the park should make arrangements to police the area for trash immediately following their event. Dumping and personal household disposal is prohibited in the park.
13. Picnic tables are available for your use and should remain in the pavilion.
14. Fires are prohibited in the City Park except in the barbecue grills, in non-wooded areas. Permanent grills are provided for your use. All grill fires must be attended and hot coals extinguished before leaving.
15. All animals visiting the Park must be leashed according to section 505.01
16. All youth gatherings must be chaperoned by an adult, recommended ratio is 10 children (or less) to one adult.
17. No loud music or disorderly conduct is permitted.
18. The Parks and Recreation Department is not responsible for any items left in the Park.
19. The City Park is the home for over 150 types of plants and trees, for your enjoyment. Removal or malicious damage to plants, trees or animals will not be tolerated, and will be considered destruction of public property.
20. Firearms of any kind are prohibited except those carried by on-duty Streetsboro Police Officers.
21. No hunting within the City Park limits.
22. The City Park is governed, in addition to the above-mentioned rules and regulations, by all local, state and federal laws involving public property.
23. The City of Streetsboro is not responsible for personal injury obtained during the use of parkland or facilities.

Failure to comply with the above rules and regulations or any prevailing city, state or federal law may result in an interruption of use of park properties.
