## SENIOR CITIZENS/ RETIREES

Retirement income is NOT subject to Streetsboro income tax. The proposal will NOT increase taxes for our Senior Citizens.



However, like all Streetsboro Residents, our Senior Citizens will benefit from the numerous programs and services the increased revenue generated by the successful passing of this issue will provide.



## RESIDENTS WORKING OUTSIDE OF STREETSBORO

Municipal income taxes are paid to the city where individuals work and the money is not shared with the city where an employee lives. Therefore, *your taxes* go to your employer's city to protect and provide services only to their residents.

There are approximately 5,500 Streetsboro residents who work outside of the city. The proposed program would result in tax relief to residents who pay municipal income tax to another city equal to the proposed new tax rate of 2%. The estimated tax relief is an average of \$218 per tax payer per year.

Streetsboro residents who work outside of the city and pay 2% through their employer will receive credit and will no longer be required to pay the additional tax to RITA. People who

pay less than 2% through their employer will pay the difference to the City of Streetsboro. For example, if you pay 1½% through your employer, then you will only need to pay ½% to RITA upon passage of the new tax relief program.



## RESIDENTS WORKING IN STREETSBORO

There are approximately 1,800 individuals who will pay 1% more than they have previously been paying upon approval of the tax relief program. However, individuals who itemize deductions for their federal tax return will recoup some of the additional taxes paid to their municipality by the increased deductions for local taxes paid.



## As Our City Grows...

This calls for changing the municipal income tax rate from 1% to 2% while providing full credit for municipal income tax paid to another tax authority up to the proposed new rate of 2%.

If you are among the majority of Streetsboro Residents who live in Streetsboro and pay 2% to another tax district, **this proposed tax relief will NOT cost you 1 cent!**
